Have your exact fee ready at the time of surgery. See the enclosed fee schedule for the acceptable forms of payment.
Bring your signed consent form(s) with you. Read it at home and have it signed and/or initialed in all the designated areas. This does not need to be signed or witnessed in front of a staff member.
Bring your prescription with you on surgery day. PLEASE: DO NOT TAKE THE VALIUM, OR USE THE LOTEMAX OR VIGAMOX UNTIL YOU ARE INSTRUCTED TO DO SO IN OUR OFFICE. Systance Refresh
Purchase additional preservative free tears. During your initial evaluation we may have supplied you with a coupon for Preservative Free Tears. You will need to pick up additional Preservative Free Tears (see images) as they will be used very frequently for a month after surgery. We recommend you purchase an economy size box (usually between 70 – 150 vials) and have them available for use after your procedure. Preservative free tears are NOT sold in bottles.
Please make sure you have arranged for a driver to pick you up after surgery. Plan to be at the office for approximately 1 hour from your time of arrival. You may have someone join you for post-operative instructions, or, if you prefer, our front office will take the name and phone number of your driver and contact them 15 minutes before you are scheduled to leave the office.

- **Pre-book your next 3 follow up appointments.** After LASIK procedures it is imperative that you are seen at regular intervals to monitor your recovery. These appointments will be arranged at our office, or with prior approval, can be arranged with your regular eye doctor. Your follow up appointments for the next year will be as follows:
 - 1-day at Clear Advantage (approx. 10 minutes)

Clear Advantage

- 3-day at Eyesight Ophthalmic Services in Dover to see Dr. Peters (approx. 10 minutes)
- 1-week at Clear Advantage (approx. 10 minutes)
- 1-month at Clear Advantage or your eye doctor (approx. 10 minutes)
- 3-months at Clear Advantage or your eye doctor (approx. 10 minutes)
- 6-months or 1 year at Clear Advantage or your eye doctor (approx. 10 minutes)

If you need to reschedule your surgery, or have not chosen a date and time after your evaluation: Surgery days are every Thursday between the hours of 10:00am and 6:00pm as well as one Friday per month between 9:45am and 4:00pm.

You will be seen for a 1-day follow up on Friday (8:30-10:45am) or Saturday (8:00-9:00am) depending on your surgery date.
